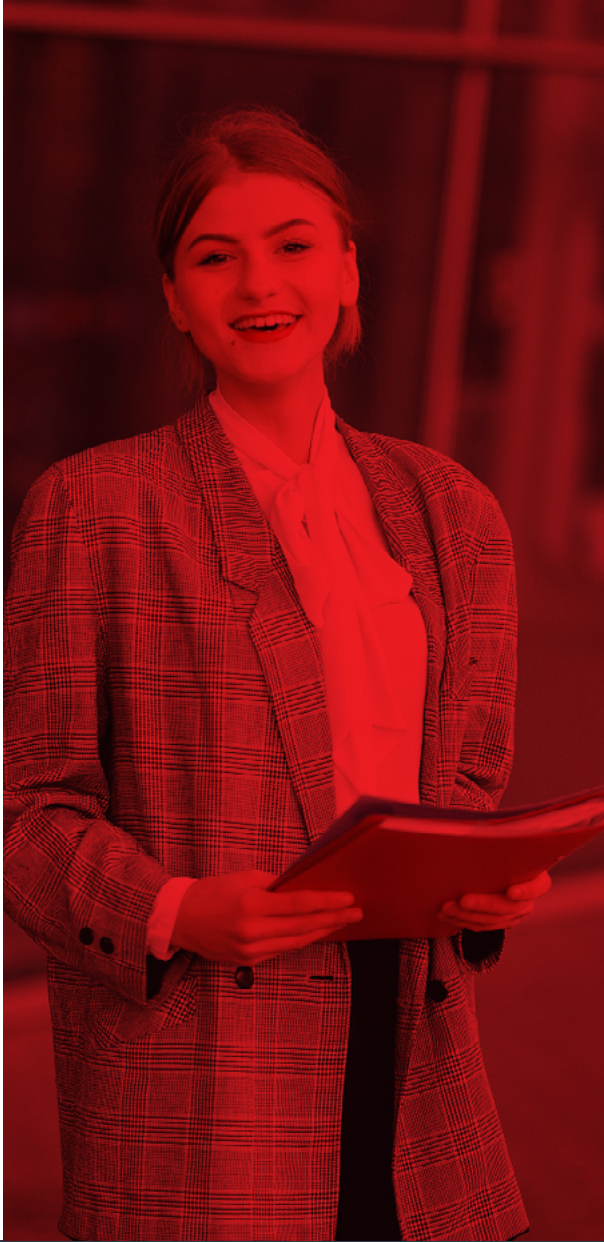


CAREER PROSPECTS
